C) Use the scenario below to answer the questions that follow:

Ms Rita from Windhoek approached your company and placed an order for 15 Range Rovers on the 12th of November 2018. She wants all her cars delivered on the 19th of November 2018. However, your company does not have stocks of the required cars and it would take six (6) calendar days to have the cars (material availability) in stocks from the day of order placement. You are also told that:

- It takes you a day to organize transport for Ms Rita's order (transport scheduling date)
- It takes two calendar days to load all the fifteen Range Rovers into a haulage truck
- It would take one day to deliver the cars (transit time) at Ms Rita's house
- Your company is closed on Sunday and public holidays.
- The 20th of November is a public holiday.
 - Compute the date of product delivery clearly showing all your workings and the formula used.
