Match the steps in the shipping process column A with their freight forwarding activities in Column B. There are more than one activity for one step. Write down the number of the shipping process and the letter (s) of activity (or activities) that are matching with that shipping process.

Column A: Shipping Process	Column B: Freight Forwarding Activities
1) Original handling	a) Arranging for the physical transfer of consignment from shippers to the forwarder premises, origin warehouse.
2) Import haulage	b) Shipment planning, Carrier selection & Mode selection.
3) destination handling	c) Transferring of the cargo from the import warehouse to the consignee address and the cargo's final destination.
4) Import customs clearance	d) Controlling the receiving and verifying of all documentation before submitting the original carrier bill of lading the relevant authorities for a formal declarations to register and levy any customs duty on shipment.
5) Ocean/air freight	e) Arranging for the collection of the container at the port and deliver it to the destination warehouse.
6) Export Haulage	f) Unloading the container and submitting documents for import clearance through customs.
7) Export custom clearance	g) Determines freight charges for a shipment and advice shippers before billing by the carrier to avoid overcharges or undercharges.
	h) Investigating the market and conducting the charter rate negotiations on behalf of the charterer.
	i) Book a container and a slot on board the vessel, arranges loading of the container and shipping documentation from port of origin to port of destination.
	j) Communicating and meeting the timelines for shipping.
	k) Tracking the cargo.
	l) Coordinate different parties involved in all the physical handling and inspection of the cargo from receiving it at the origin warehouse.
