QUESTION 2 [24 MARKS]

Please indicate which scenarios are compliant with the Namibian public procurement law. For each scenario, indicate Compliant or Non-compliant. Your judgment is sorely based on the information provided. Please note all the scenarios are for public entities regulated by the Procurement Act of 2015, its amendments and regulations.

Each scenario is worth two marks.

- A company issued an advert on all Namibian circulated media print, its website and the E-GP system sourcing for a supplier for a Toyota Fortuner 4x4 2024-year model.
- 2. A company used restricted bidding to procure cleaning materials worth N\$ 30 million.
- 3. A category two public entity issued a tender to procure vehicles worth N\$ 15 million.
- 4. A company issued a request for quotation to procurer a consultant to develop their 5-year strategic plan.
- 5. A company used direct procurement to procure stationery worth N\$ 1.5 million.
- 6. A company directly engaged MTC to provide them with daily SMS services.
- A category one public entity advertised a tender to construct service stations across the country worth N\$ 150 million.
- 8. An entity used emergency procurement to acquire stationeries for daily operations.
- 9. The Oshakati Hospital restricted beef procurement only from abattoirs north of the veterinary cordon fence approved by the Meat Board of Namibia.
- 10. A company awarded a bid to a bidder whose price was the third lowest because they scored 8% on the margin of preference. Thus, they reduced their price by 8% for evaluation purposes only.
- 11. A company advertised an open national bid to procure Covid 19 vaccines.
- 12. A company advertised an open international bid to procure promotional items such as t-shirts, caps, etc., for an upcoming survey.

SECTION B [60 MARKS]

QUESTION 3 [40 MARKS]

XYZ company was notified as the successful bidder for a tender worth \$120 million to supply condoms to the Ministry of Health. In line with the country procurement act, the procuring entity published the notice of selection for the award on their company website, giving a chance for other unsuccessful bidders to submit applications for review within seven days.

The second runner-up bid was at N\$ 68.5 million, but XYZ was awarded as it was regarded as a local manufacturer, although this wasn't a requirement in the bidding document. More so, the company employed only 5 employees, and the certificate of registration of a factory was issued three months before the tender was advertised.

Inquiries later revealed that the company was not a manufacturing company but was repackaging imported pharmaceutical products. The country has been reported to be out of stock of critical drugs, such as medication for hypertension and epilepsy is threatening to bring state facilities to their knees. Also, the major hospital is reported to be dilapidated. The procuring entity resulted in issuing a public notice announcing the cancellation of the tender citing section 54 (1) (b), which allows public entities to cancel if the lowest evaluated bid is substantially above the applicable cost estimate.
