4) THE RELEVANCE OF THE COOPERATIVE PRINCIPLE FOR SPEECH ANALYSIS.....[Marks: 50%]

Grice's maxims of conversation are a collection of maxims to describe principles that people intuitively follow to guide their conversations, make their communicative efforts effective, and minimize misunderstandings. Grice's (1975) co-operative principle views conversation as a rational and cooperative activity among humans. In order to have a meaningful exchange of information, speakers cooperate with each other and implicitly follow a series of conversational maxims or rules (Grice, 1975). Paul Grice (1975) argues that when we communicate, we assume, without realizing it, that we, and the people we are talking to, will be conversationally cooperative to achieve mutual conversational ends. What does the Cooperative Principle of Grice mean to all of us in the 21st century? Can these principles improve everyday conversations? Can the principles improve our daily communication systems at all? In line with these principles and factors, write an essay analysing the statement below by the late H.E. Dr Hage Geingob, former President of the Republic of Namibia at the African Peer-Review Mechanism Forum of Heads of State and Government on 28 January 2017 in Addis Ababa, Ethiopia.
